Rating Rationale

Acuité has reaffirmed the short term rating of '**ACUITE A4**' (read as **ACUITE A four**) on the Rs. 25.00 crore bank facilities of Mukteshwar Sugar Mills Limited. The rating continues to be flagged as "Issuer Not-Cooperating" and is based on best available information.

About the Company

Aurangabad-based, Mukteshwar Sugar Mills Limited was incorporated in 2007, as Public Limited (Unlisted) company. The company is promoted by Mr. Sachin Bhausaheb Nikam (Chairman) and Mr. Prashant Motilal Sharma (Director). MSML is engaged in manufacturing of Sugar with a licensed capacity of 2500 tons of cane per day.

Non-cooperation by the issuer/borrower:

Acuité has been requesting for data, information and undertakings from the rated entity for conducting surveillance & review of the rating. However, the issuer/borrower failed to submit such information before the due date. Acuité believes that information risk is a critical component in such ratings, and noncooperation by the issuer along with unwillingness to provide information could be a sign of potential deterioration in its overall credit quality. This rating is, therefore, being flagged as "Issuer not-cooperating", in line with prevailing SEBI regulations and Acuité's policies.

Limitation regarding information availability:

The rating is based on information available from sources other than the issuer/borrower (in the absence of information provided by the issuer/borrower). Acuité endeavoured to gather information about the entity/ industry from the public domain. Therefore, Acuité cautions lenders and investors regarding the use of such information, on which the indicative credit rating is based.
