Rating Rationale

Acuite has reaffirmed the short term rating of '**ACUITE A4**' (read as **ACUITE A four**) on the Rs. 25.00 crore bank facilities of Mukteshwar Sugar Mills Limited. The rating continues to be flagged as "Issuer Not-Cooperating" and is based on the best available information.

About the Company

Aurangabad-based, Mukteshwar Sugar Mills Limited was incorporated in 2007, as Public Limited (Unlisted) company. The company is promoted by Mr. Sachin Bhausaheb Nikam (Chairman) and Mr. Prashant Motilal Sharma (Director). MSML is engaged in manufacturing of Sugar with a licensed capacity of 2500 tons of cane per day.

Non-cooperation by the issuer/borrower:

Acuite has been requesting for data, information and undertakings from the rated entity for conducting surveillance & review of the rating. However, the issuer/borrower failed to submit such information before the due date. Acuite believes that information risk is a critical component in such ratings, and noncooperation by the issuer along with unwillingness to provide information could be a sign of potential deterioration in its overall credit quality.
