Rating Rationale

Acuite has reviewed the long-term rating of '**ACUITE B+**' (read as **ACUITE B plus**) and the short term rating of '**ACUITE A4**' (read as **ACUITE A four**) on the Rs.15.00 crore bank facilities of Mittal Timber Store. This rating is now an indicative rating and is based on best available information.

Established in 1975, Mittal Timber store is a proprietary concern promoted by Sh. Krishan Mittal. The firm is engaged in import, sawing and whole sale trading in timber by import of wood from Malaysia, Indonesia, Nigeria, South Africa, Canada, New Zealand and other countries. The firm has its branch office and warehouse at Gandhidham (Gujarat) where the imported timbers are stored. Apart from this the Firm is having its Head office at Karnal. The timber imported in the shape of logs is either sawed into different sizes at Gandhidham by the Firm saw mills or sold on high seas basis or sawn timber.

Non-cooperation by the issuer/borrower: Acuite has been requesting for data, information and undertakings from the rated entity for conducting surveillance & review of the rating. However, the issuer/borrower failed to submit such information before due date.

This rating is therefore being flagged as "Issuer not-cooperating", in line with prevailing SEBI regulations and Acuite's policies.
