Rating Rationale

Acuité has downgraded the long-term rating to '**ACUITE D**' (read as **ACUITE D**) from '**ACUITE B+**' (read as **ACUITE B plus**) on the Rs. 10.50 crore bank facilities of Asian Firdaus Cashews (AFC). This rating is now an indicative rating and is based on best available information.

The downgrade is in view of delays in servicing the debt obligation. The account is NPA on account of overdrawings in CC account and packing credit account.

In the year 1995 Mr. S Pillai, first generation industrialist, established Asian Firdaus Cashews (AFC) as a proprietorship firm in Kollan, Kerala. AFC is engaged in processing and trading of quality cashew kernels. Current promoter Mr. Shinas Asanarupillai, son of Mr. S Pillai, joined the firm in 2003 and expanded the business across geographies.

Non-cooperation by the issuer/borrower:

Acuité has been requesting for data, information and undertakings from the rated entity for conducting surveillance & review of the rating. However, the issuer/borrower failed to submit such information before due date.

This rating is therefore being flagged as "Issuer not-cooperating", in line with prevailing SEBI regulations and Acuité's policies.
