Acuité has reviewed long-term rating of '**ACUITE B**' (read as **ACUITE B**) and short-term rating of '**ACUITE A4**' (read as **ACUITE A four**) on the Rs. 9.50 crore bank facilities of BALA INDUSTRIES (BI). This rating is now an indicative rating and is based on best available information.

Established in 1997 by Mr. S A Arutchelvan, Bala Industries is a Chennai (Tamil Nadu) based partnership firm engaged in manufacture of power and distribution transformers. The entity mainly supplies transformers to Tamil Nadu Generation and Distribution Corporation Limited (TANGEDCO). The entity also supplies wind mill transformers to RRB Energy Ltd and Para Enterprises. The entity is promoted by Mr. S A Arutchelvan and Mrs. A Anuradha. The entity has an associate concern, namely, Paramount Industries, which is also engaged in manufacture of power and distribution transformers.

Non-cooperation by the issuer/borrower

Acuité has been requesting for data, information and undertakings from the rated entity for conducting surveillance & review of the rating. However, the issuer / borrower failed to submit such information before due date.

This rating is therefore being flagged as "Issuer not-cooperating", in line with prevailing SEBI regulations and Acuité's policies.
