Rating Rationale

Acuite has reaffirmed the long-term rating of '**ACUITE B**' (read as **ACUITE B**) and the short term rating of '**ACUITE A4**' (read as **ACUITE A four**) on the Rs. 9.50 crore bank facilities of Bala Industries (BI). The rating continues to be flagged as "Issuer Not-Cooperating" and is based on best available information.

About the Company

Established in 1997 by Mr. S A Arutchelvan, Bala Industries (BI) is a Chennai (Tamil Nadu) based partnership firm engaged in the manufacture of power and distribution transformers. The entity mainly supplies transformers to Tamil Nadu Generation and Distribution Corporation Limited (TANGEDCO). The entity also supplies windmill transformers to RRB Energy Limited and Para Enterprises. The entity is promoted by Mr. S A Arutchelvan and Mrs. A Anuradha.

About the Group

Bala Industries (BI) has an associate concern namely Paramount Industries (PI), which is also engaged in manufacture of power and distribution transformers. Established in 1997, Chennai (Tamil Nadu) based Paramount Industries is engaged in the manufacture of power and distribution transformers. The group mainly supplies transformers to Tamil Nadu Generation and Distribution Corporation Limited (TANGEDCO). The group is promoted by Mr. S A Arutchelvan.

Non-cooperation by the issuer/borrower:

Acuite has been requesting for data, information and undertakings from the rated entity for conducting surveillance & review of the rating. However, the issuer/borrower failed to submit such information before the due date.

Acuite believes that information risk is a critical component in such ratings, and non-cooperation by the issuer along with unwillingness to provide information could be a sign of potential deterioration in its overall credit quality.

This rating is, therefore, being flagged as "Issuer not-cooperating", in line with prevailing SEBI regulations and Acuite's policies.

Limitation regarding information availability:

The rating is based on information available from sources other than the issuer/borrower (in the absence of information provided by the issuer/borrower). Acuite endeavored to gather information about the entity/industry from the public domain. Therefore, Acuite cautions

lenders and investors regarding the use of such information, on which the indicative credit rating is based.
