Rating Rationale

Acuité has downgraded the long-term rating to 'ACUITE B-' (read as ACUITE B minusf)rom 'ACUITE B' (read as ACUITE B) on the Rs. 6.26 crore bank facilities of Kemron Wood Plast Private Limited (KWPPL). The rating continues to be flagged as "Issuer Not-Cooperating" and is downgraded on account of information risk.

About the Company

Kemron Wood Plast Private Limited (KWPPL), based at Rajkot (Gujarat), was incorporated in June, 2015 and the commercial operations commenced from July, 2016. KWPPL is promoted by Manhar Bhuva, Nikul Bhuva, Ashish Gondaliya and Ketan Sangani. The company is a manufacturer and supplier of PVC Sheet, WPC Sheet, PVC Foam Board, among others.

Non-cooperation by the issuer/borrower:

Acuité has been requesting for data, information and undertakings from the rated entity for conducting surveillance & review of the rating. However, the issuer/borrower failed to submit such information before the due date. Acuité believes that information risk is a critical component in such ratings, and non-cooperation by the issuer along with unwillingness to provide information could be a sign of potential deterioration in its overall credit quality. This rating is, therefore, being flagged as "Issuer not-cooperating", in line with prevailing SEBI regulations and Acuité's policies.

Limitation regarding information availability

This rating is based on information available from sources other than the issuer / borrower (in the absence of information provided by the issuer / borrower). Acuite endeavoured to gather information about the entity/industry from the public domain.
