Rating Rationale

Acuite has downgraded the long-term rating to '**ACUITE B+ (read as ACUITE B plus)**' from '**ACUITE BB- (read as ACUITE double B minus)**' on the Rs. 8.00 crore bank facilities of Shree Krishna Packaging (SKP) on account of information risk. The rating continues to be flagged as "Issuer Not-Cooperating" and is based on the best available information.

About the Company

Established in 2010, Shree Krishna Packaging (SKP) is a partnership firm engaged in manufacturing of new LPG cylinders. The manufacturing facility is located in Kala Amb, Himachal Pradesh with installed capacity of 6 lakhs cylinders per annum. The firm is promoted by Mr. Surender Jain who looks after the day to day operations and Mr. Manish Jain. The firm caters to reputed oil companies.

Non-cooperation by the issuer/borrower:

Acuite has been requesting for data, information and undertakings from the rated entity for conducting surveillance & review of the rating. However, the issuer/borrower failed to submit such information before the due date. Acuite believes that information risk is a critical component in such ratings, and non-cooperation by the issuer along with unwillingness to provide information could be a sign of potential deterioration in its overall credit quality. This rating is, therefore, being flagged as "Issuer not-cooperating", in line with prevailing SEBI regulations and Acuite's policies.
