Rating Rationale

Acuite has reaffirmed the long-term rating of ‘**ACUITE B-**’ (read as **ACUITE B minus**) on Rs. 6.75 crore bank facilities of Incotex Impex Private Limited (IIPL). The rating continues to be flagged as “Issuer Not Co-operating” and is based on the best available information.

About the Company

Mumbai based, Incotex Impex Private Limited (IIPL), incorporated in 1995 by Mr. Arun Todi. It is engaged in manufacturing and export of home textile products like bed sheets, cushion covers, curtains etc under the brand name of other companies.

Non-cooperation by the issuer/borrower:

Acuite has been requesting for data, information and undertakings from the rated entity for conducting surveillance & review of the rating. However, the issuer/borrower failed to submit such information before the due date.
