**Rating Rationale**

Acuite has reaffirmed the short-term rating of ‘**ACUITE D**’ (read as **ACUITE Do**) on the Rs. 13.20 Crore bank facilities of Herald Multiventures Private Limited (HMPL). The rating continues to be flagged as “Issuer Not-Cooperating” and is based on best available information.

**About the Company**

Mumbai-based, Herald Multiventures Private Limited (HMPL) was incorporated in 2015. The company, promoted by Mr. Radheya Khanolkar and Mr. Pramod Patil, is engaged in software development and providing IT solutions. HMPL has a subsidiary in Dubai with the name Genesis Technologies FZE (GTF). The firm is engaged in trading of electronic goods. HMPL has given Standby Letter of Credit in favour of lenders of GTF.

**Unsupported Rating**

**Non-cooperation by the issuer/borrower:**

Acuite has been requesting for data, information and undertakings from the rated entity for conducting surveillance & review of the rating. However, the issuer/borrower failed to submit such information before the due date. Acuite believes that information risk is a critical component in such ratings, and non-cooperation by the issuer along with unwillingness to provide information could be a sign of potential deterioration in its overall credit quality. This rating is, therefore, being flagged as “Issuer not-cooperating”, in line with prevailing SEBI regulations and Acuite’s policies.

**Limitation regarding information availability**

This rating is based on information available from sources other than the issuer / borrower (in the absence of information provided by the issuer / borrower) . Acuite endeavoured to gather information about the entity/industry from the public domain.
