Rating Rationale

Acuite has downgraded the long-term rating to 'ACUITE B' (read as ACUITE Bf) from 'ACUITE B+' (read as ACUITE B plus) and reaffirmed the short term rating of 'ACUITE A4' (read as ACUITE A four) on the Rs. 6.00 crore bank facilities of Benco Thermal Technologies Private Limited (BTTPL) on account of information risk. The rating continues to be flagged as "Issuer Not-Cooperating" and is based on the best available information.

About the Company

Benco Thermal Technologies Private Limited (BTTPL) was incorporated in 1988 in Chennai. It is engaged in the manufacturing of heat treat furnaces and associated equipment. The Directors are Mr. Panchapakesan Ramachandran, Mr. Raghavan Rangarajan and Mr. Ramachandran Jayalakshmi. The main raw materials required are iron and steel which are procured from local players of Chennai. The key customers are Ordinance factory, Metro Steel Ind., RAD-CON Inc., to name a few.

Non-cooperation by the issuer/borrower:

Acuite has been requesting for data, information and undertakings from the rated entity for conducting surveillance & review of the rating. However, the issuer/borrower failed to submit such information before the due date.
