Rating Rationale

Acuité has reaffirmed the long-term rating to '**ACUITE B+**' (read as **ACUITE single B plus**) and reaffirmed the short term rating to '**ACUITE A4**' (read as **ACUITE A four**) on the Rs. 35.00 crore bank facilities of S T Constructions Private Limited (STCPL). The rating continues to be flagged as "Issuer Not-Cooperating" and is based on best available information.

About the Company

STCPL, incorporated in 2002, is a Delhi-based company promoted by Mr. Surish Tiwary and Mrs. Shobha Tiwary. The company undertakes civil construction work for government organisations including Indian Railways, Noida/Greater Noida Authority, Rail India Technical and Economic Service (RITES) India Ltd., Meerut Development Authority, to name a few.

Non-cooperation by the issuer/borrower:

Acuité has been requesting for data, information and undertakings from the rated entity for conducting surveillance & review of the rating. However, the issuer/borrower failed to submit such information before the due date.

Acuité believes that information risk is a critical component in such ratings, and non-cooperation by the issuer along with unwillingness to provide information could be a sign of potential deterioration in its overall credit quality.

This rating is, therefore, being flagged as "Issuer not-cooperating", in line with prevailing SEBI regulations and Acuité's policies.

Limitation regarding information availability:

The rating is based on information available from sources other than the issuer/borrower (in the absence of information provided by the issuer/borrower). Acuité endeavoured to gather information about the entity/ industry from the public domain. Therefore, Acuité cautions lenders and investors regarding the use of such information, on which the indicative credit

ratings based.
