

Rating Rationale

Acuité has reaffirmed the long-term rating to 'ACUITE D' (read as ACUITE D) on the Rs. 6.30 crore bank facilities of Lath Sachidananda Agro Private Limited (LSAPL). The rating continues to be flagged as "Issuer Not-Cooperating" and is based on the best available information.

About the Company

Lath Sachidananda Agro Private Limited (LSAPL), an Odisha based company, was incorporated in the year 2017 by Mr. Anubhaw Lath and Ms. Sapna Lath. The company is setting up a cold storage facility. Apart from this, the promoters are also involved in agricultural activities.

Non-cooperation by the issuer/borrower:

Acuité has been requesting for data, information and undertakings from the rated entity for conducting surveillance & review of the rating. However, the issuer/borrower failed to submit such information before the due date.
