Rating Rationale

Acuité has downgraded the long-term rating to 'ACUITE B' (read as ACUITE B) from 'ACUITE B+' (read as ACUITE B plus) and reaffirmed the short-term rating of 'ACUITE A4' (read as ACUITE A four) on Rs. 34.00 crore bank facilities of Mod Forge Private Limited (MFPL). The rating continues to be flagged as "Issuer Not-Cooperating" and is downgraded on account of information risk.

About the Company

Mod Forge Private Limited (MFPL) is a Chennai based company incorporated in the year 1988 by Mr. Om Prakash Modi, first generation entrepreneur having more than four decades of experience. Mr. Modi is supported by his son Mr. Abhishek Modi as a Managing director and his daughter in law Mrs. Asha Modi as a director. Mr. Abhishek Modi has been instrumental in scaling up the business operations. Mod forge Private Limited is engaged in manufacturing and supply of Bright steel bars, Forging, Machine components and fasteners for Automobile, Defense industry.

Non-cooperation by the issuer/borrower:

Acuité has been requesting for data, information and undertakings from the rated entity for conducting surveillance & review of the rating. However, the issuer/borrower failed to submit such information before the due date.
