Rating Rationale

Acuité has downgraded the long-term rating to '**ACUITE B**' (read as **ACUITE B**) from '**ACUITE B+**' (read as **ACUITE B plus**) on the Rs. 11.50 crore bank facilities of Nile Overseas on account of information risk. The rating continues to be flagged as "Issuer Not-Cooperating" and is based on the best available information.

About the Company

Established in 2014, Nile Overseas is a Panipat (Haryana) based partnership firm promoted by Mr. Jasvir Singh Jaglan and Mrs. Jyoti Jaglan. The firm is engaged in the manufacture and wholesale of mink blanket from polyester yarn with an installed capacity of 3600 tonnes per annum. The day to day operations are managed by Mr. Jasvir Singh Jaglan.

Unsupported Rating

Non-cooperation by the issuer/borrower:

Acuité has been requesting for data, information and undertakings from the rated entity for conducting surveillance & review of the rating. However, the issuer/borrower failed to submit such information before the due date. Acuité believes that information risk is a critical component in such ratings, and non-cooperation by the issuer along with unwillingness to provide information could be a sign of potential deterioration in its overall credit quality. This rating is, therefore, being flagged as "Issuer not-cooperating", in line with prevailing SEBI regulations and Acuité's policies.
