Acuité has reviewed long-term rating of '**ACUITE BB-**' (**read as ACUITE double B minus**) and short-term rating of '**ACUITE A4**' (**read as ACUITE A four**) on the Rs. 6.27 crore bank facilities of SHREE HARI STEEL AND ALLOYS (SHSA). This rating is now an indicative rating and is based on best available information.

Tamil Nadu based, SHSA established in 2005 is engaged in manufacturing of Carbon steel, Low Alloy steel, Stainless steel and Duplex steel castings. The partners of the firm are Mr. K. Subbain, Mr. R. Sivakumar, Mr. M. Nagarajan and Mr. M. Ranganathan.
