Rating Rationale

Acuite has downgraded the long-term rating to 'ACUITE B-' (read as ACUITE B minus) from 'ACUITE B' (read as ACUITE B) and reaffirmed the short-term rating of 'ACUITE A4' (read as ACUITE A four) on the Rs. 6.27 crore bank facilities of Shree Harie Steel And Alloys. The rating continues to be flagged as "Issuer Not-Cooperating" and is downgraded on account of information risk.

About the Company

Tamil Nadu based, Shree Harie Steel And Alloys was established in 2005 is engaged in manufacturing of Carbon steel, Low Alloy steel, Stainless steel and Duplex steel castings. The partners of the firm are Mr. K. Subbain, Mr. R. Sivakumar, Mr. M. Nagarajan and Mr. M. Ranganathan.

Non-cooperation by the issuer/borrower:

Acuite has been requesting for data, information and undertakings from the rated entity for conducting surveillance & review of the rating. However, the issuer/borrower failed to submit such information before the due date. Acuite believes that information risk is a critical component in such ratings, and non-cooperation by the issuer along with unwillingness to provide information could be a sign of potential deterioration in its overall credit quality. This rating is, therefore, being flagged as "Issuer not-cooperating", in line with prevailing SEBI regulations and Acuite's policies.
