**Rating Rationale**

Acuite has reaffirmed the long term rating of '**ACUITE B+**' (read as **ACUITE B plus**) and short term rating of '**ACUITE A4**' (read as **ACUITE A four**) on the Rs. 44.00 crore bank facilities of Dugar Polymers Limited (DPL). The rating continues to be flagged as "Issuer Not-Cooperating" and is based on best available information.

**About the Company**

Dugar Polymers Limited (DPL) was incorporated in the year of 2003 and promoted by Mr. Manoj Kumar Dugar, Mr. Rajesh Kumar Dugar. DPL is primarily into manufacturing of plastic sheets, plastic bars, PVC compound, stretch films etc. These products find various industrial applications like partition, linings, flooring, roofs and cable compound. DPL has three manufacturing facilities out of which, two are located at Dadra & Nagra Haveli and one is located in Surat with an overall installed production capacity of 1200 metric tonnes per month. DPL also functions as a Del Credere Agent (DCA) for Indian Oil Corporation Limited with respect to the sale of polymer products, situated at Hyderabad. The agency division commenced its operations from the year 2011. DPL caters to the customer throughout the country on the basis of its strong marketing team in each of the four zones.

**Non-cooperation by the issuer/borrower:**

Acuite has been requesting for data, information and undertakings from the rated entity for conducting surveillance & review of the rating. However, the issuer/borrower failed to submit such information before the due date. Acuite believes that information risk is a critical component in such ratings, and non-cooperation by the issuer along with unwillingness to provide information could be a sign of potential deterioration in its overall credit quality. This rating is, therefore, being flagged as "Issuer not-cooperating", in line with prevailing SEBI regulations and Acuite's policies.

**Limitation regarding information availability:**

The rating is based on information available from sources other than the issuer/borrower (in

the absence of information provided by the issuer/borrower). Acuité endeavored to gather information about the entity/industry from the public domain. Therefore, Acuité cautions lenders and investors regarding the use of such information, on which the indicative creditrating is based.
