King Sumitra Trailers (KST), a partnership firm based at Mumbai, was established in 1988. The firm is a manufacturer and supplier of trailers, semi-trailers and it specialises in running gear trailers. The partners of the firm are Mr. Suresh Kumar Arora and Mrs. Lata Arora. KST caters to very niche and specialized sector of LPG tankers/Running Gears.

Non-cooperation by the issuer/borrower
