Acuité has downgraded the long term rating to '**ACUITE B+** (**read as ACUITE B plus**) from '**ACUITE BB-** (**read as ACUITE BB minus**) on the Rs.5.00 crore bank facilities of King Sumitra Trailers (KST). The rating continues to be flagged as "Issuer Not-Cooperating" and is downgraded on account of information risk.

King Sumitra Trailers (KST), a partnership firm based at Mumbai, was established in 1988. The firm is a manufacturer and supplier of trailers, semi-trailers and it specializes in running gear trailers. The partners of the firm are Mr. Suresh Kumar Arora and Mrs. Lata Arora. KST caters to a very niche and specialized sector of LPG tankers/Running Gears.

Non-cooperation by the issuer/borrower:

Acuité has been requesting for data, information and undertakings from the rated entity for conducting surveillance & review of the rating. However, the issuer/borrower failed to submit such information before the due date.

This rating continues to be flagged as "Issuer not-cooperating", in line with prevailing SEBI regulations and Acuité's policies.
