Rating Rationale

Acuité has reaffirmed the long-term rating of '**ACUITE B-**' (read as **ACUITE B minus**) on the Rs. 16.00 crore bank facilities of Ajay Industrial Polymers Private Limited. The rating continues to be flagged as "Issuer Not-Cooperating" and is based on best available information.
