Rating Rationale

Acuite has reaffirmed the long-term rating of '**ACUITE C**' (read as **ACUITE C**) and the short-term rating of '**ACUITE A4**' (read as **ACUITE A four**) on the Rs. 21.00 crore bank facilities of Bhati Associates Private Limited (BAPL). The rating continues to be flagged as "Issuer Not Cooperating" and is based on the best available information.

About the Company

Bhati Associates Private Limited (BAPL) was established in 1996 as a proprietor firm based in Delhi by Mr. Harish Chowdhary. In 2004 the firm was converted to private Limited company and was promoted by Mr. Harish Chowdhary and Mr. Satish Chowdhary. BAPL is a civil contractor for government authorities. BAPL business includes infrastructure construction like Roads, Highways, Building for government authorities on a tender basis.

Non-cooperation by the issuer/borrower:

Acuite has been requesting for data, information and undertakings from the rated entity for conducting surveillance & review of the rating. However, the issuer/borrower failed to submit such information before the due date. Acuite believes that information risk is a critical component in such ratings, and non-cooperation by the issuer along with unwillingness to provide information could be a sign of potential deterioration in its overall credit quality. This rating is, therefore, being flagged as "Issuer not-cooperating", in line with prevailing SEBI regulations and Acuite's policies.
