Acuite has withdrawn the short-term rating of '**ACUITE A4**' (read as **ACUITE A four**) on the Rs. 9.50 crore bank facilities of GAUTAM GRAINS STORES (GGS).

The firm is engaged in storage and trading/exports of agricultural commodities, particularly rice. The commercial operations of the firm started in 2015. The processing and warehouse unit is located in Gandhidham (Gujarat).
