Rating Rationale

Acuité has reaffirmed the long-term rating of '**ACUITE B+**' (read as **ACUITE B Plus**) on the Rs.16.00 crore bank facilities of Rathna Stores Firm Purusai. The rating continues to be flagged as "Issuer Not-Cooperating" and is based on best available information.

About the Company

Established in 1984, Rathna Stores Firm Purusai (RSFP) is a partnership firm engaged in trading of home appliances and consumer durables. The store is spread over 57,600 sq. feet located in Purasawalkam (Chennai). The firm is promoted by Mr. S. Sivashankar.

Non-cooperation by the issuer/borrower:

Acuité has been requesting for data, information and undertakings from the rated entity for conducting surveillance & review of the rating. However, the issuer/borrower failed to submit such information before the due date.

This rating is therefore being flagged as "Issuer not-cooperating", in line with prevailing SEBI regulations and Acuité's policies.
