## Rating Rationale

Acuite has downgraded the long-term rating to '**ACUITE B**' (read as **ACUITE B**) from '**ACUITE B+**' (read as **ACUITE B Plus**) on the Rs. 16.00 crore bank facilities of Rathna Stores Firm Purusai on account of information risk. The rating continues to be flagged as "Issuer Not Co-operating" and is based on best available information.

## About the Company

Established in 1984, Rathna Stores Firm Purusai is a partnership firm engaged in trading of home appliances and consumer durables. The store is spread over 57,600 sq. feet located in Purasawalkam (Chennai). The firm is promoted by Mr. S. Sivashankar.

## Non-cooperation by the issuer/borrower:

Acuite has been requesting for data, information and undertakings from the rated entity for conducting surveillance & review of the rating. However, the issuer/borrower failed to submit such information before the due date.

Acuite believes that information risk is a critical component in such ratings, and non-cooperation by the issuer along with unwillingness to provide information could be a sign of potential deterioration in its overall credit quality.

This rating is, therefore, being flagged as "Issuer not-cooperating", in line with prevailing SEBI regulations and Acuite's policies.
