Acuité has reviewed long-term rating of 'ACUITE B' (read as ACUITE B) on the Rs. 7.55 crore bank facilities of SURESH TRADERS (ST). This rating is now an indicative rating and is based on best available information.

Suresh Traders (ST), a Bangalore based proprietorship firm established in the year 2003 by Mr. Suresh. The firm is engaged in the manufacturing of curtains and trading in furnishing fabrics. The firm sells its products through whole dealers in South India, and it also operates three retail outlets in Bangalore. The firm's manufacturing facility is in Bangalore with a stitching capacity of 1000 pieces per day.

Non-cooperation by the issuer/borrower

Acuité has been requesting for data, information and undertakings from the rated entity for conducting surveillance & review of the rating. However, the issuer / borrower failed to submit such information before due date.

This rating is therefore being flagged as "Issuer not-cooperating", in line with prevailing SEBI regulations and Acuité's policies.
