Rating Rationale

Acuite has downgraded the long-term rating to '**ACUITE D**' (read as **ACUITE D**) from '**ACUITE B**' (read as **ACUITE B**) on the Rs. 7.55 crore-bank facilities of Suresh Traders. The rating continues to be flagged as "Issuer Not Cooperating" and is based on the best available information.

The rating is downgraded is on account of information risk required for review of ratings. The rating continues to be an indicative rating and is based on the best available information. The downgrade is on the basis of publicly available information that has reported about the ongoing delays in their repayments.

About the Company

Suresh Traders (ST), a Bangalore based proprietorship firm established in the year 2003 by Mr. Suresh. The firm is engaged in the manufacturing of curtains and trading in furnishing fabrics. The firm sells its products through whole dealers in South India, and it also operates three retail outlets in Bangalore. The firms manufacturing facility is in Bangalore with a stitching capacity of 1000 pieces per day.

Non-cooperation by the issuer/borrower:

Acuite has been requesting for data, information and undertakings from the rated entity for conducting surveillance & review of the rating. However, the issuer/borrower failed to submit such information before the due date. Acuite believes that information risk is a critical component in such ratings, and noncooperation by the issuer along with unwillingness to provide information could be a sign of potential deterioration in its overall credit quality. This rating continues to be flagged as "Issuer notcooperating", in line with prevailing SEBI regulations and Acuite's policies.

Limitation regarding information availability:

The rating is based on information available from sources other than the issuer/borrower (in the absence of information provided by the issuer/borrower). Acuite endeavored to gather information about the entity / industry from the public domain. Therefore, Acuite cautions lenders and investors regarding the use of such information, on which the indicative credit rating is based.
