### **Rating Rationale**

Acuité has reaffirmed the long-term rating of '**ACUITE B+**' (**read as ACUITE B plus**) on the Rs. 6.60 crore bank facilities of Amit Poultry Products. The rating continues to be flagged as "Issuer Not-Cooperating" and is based on best available information.

### **About the Company**

Amit Poultry Products (APP) is a partnership firm promoted by Mr. Rakesh Kumar Garg, Mr. Amit Garg and Mr. Nitin Garg. The firm is engaged in trading of eggs and culled birds. APP has a capacity of raising 1.5 lakh poultry birds. The firm supplies egg in the local market in Haryana via distributors.

### **Non-cooperation by the issuer/borrower:**

Acuité has been requesting for data, information and undertakings from the rated entity for conducting surveillance & review of the rating. However, the issuer/borrower failed to submit such information before the due date.

This rating is, therefore, being flagged as "Issuer not-cooperating", in line with prevailing SEBI regulations and Acuité's policies.

### **Limitation regarding information availability:**

The rating is based on information available from sources other than the issuer/borrower (in the absence of information provided by the issuer/borrower).
