Established in 2007, Anika Developers (Anika) is a Bangalore-based real estate firm promoted by Mr. A. Nagesh. It is into development of real estate projects in and around Bengaluru (Karnataka) Currently, It is developing a residential cum commercial project with total saleable area of 70 thousand square foot (sq.ft.) to construct 51 units, which include 2-bhk, 3-bhk apartments and 2 thousand sq.ft. for commercial purpose. The total cost of the projects is Rs.39.99 crore
