Rating Rationale

Acuite has reaffirmed the long-term rating of '**ACUITE B**' (read as **ACUITE B**) on the Rs. 7.50 crore bank facilities of Porwal Ginning and Pressing Private Limited. The rating continues to be flagged as "Issuer Not-Cooperating" and is based on best available information.

About the Company

Established as a partnership firm in 2005 as 'Porwal Ginning and Pressing', subsequently reconstituted as a private limited company in 2010, PGPL gins and presses cotton into cotton bales, crush seeds into seed oil and de-oiled cakes. Based in Manwath (Maharashtra), the company is promoted and managed by Mr. Jaiprakash R. Porwal and Mr. Vijayprakash R. Porwal. The company has 18 gins and extraction units with an installed capacity of 50 metric tonnes per day (MTPD).

Non-cooperation by the issuer/borrower:

Acuite has been requesting for data, information and undertakings from the rated entity for conducting surveillance & review of the rating. However, the issuer/borrower failed to submit such information before the due date.

This rating is therefore being flagged as "Issuer not-cooperating", in line with prevailing SEBI regulations and Acuite's policies.

Limitation regarding information availability:

The rating is based on information available from sources other than the issuer/borrower (in the absence of information provided by the issuer/borrower). Acuite endeavoured to gather information about the entity/ industry from the public domain. Therefore, Acuite cautions lenders and investors regarding the use of such information, on which the indicative credit rating is based.
