Rating Rationale

Acuité has withdrawn the long-term rating of '**ACUITE B+**' (read as **ACUITE B plus**) and short-term rating of '**ACUITE A4**' (read as **ACUITE A four**) on the Rs.14.00 crore bank facilities of PARMESHWAR METAL PRIVATE LIMITED (PMPL). The rating withdrawal is in accordance with Acuité's policy on withdrawal of rating. The rating continues to be flagged as "Issuer Not-Cooperating".

The rating is being withdrawn on account of request received from the company and NOC received from the banker.

Gujarat-based, Parmeshwar Metal Private Limited was incorporated in 2016 in the manufacture of copper wire rod of 1.8mm thickness and fine and superfine size of 0.40-0.50 mm diameter. The company is promoted and managed by Mr. Radheshayam Jankilal Shah, Mr. Rajendrakumar Devkinandan Shah and Mr. Shantilal Kailashchandra Shah.

Non-cooperation by the issuer/borrower

Acuité has been requesting for data, information and undertakings from the rated entity for conducting surveillance & review of the rating. However, the issuer / borrower failed to submit such information before due date.

Acuité believes that information risk is a critical component in such ratings, and non-cooperation by the issuer along with unwillingness to provide information could be a sign of potential deterioration in its overall credit quality.
