Acuité has reviewed the long-term rating of '**ACUITE D** (**read as ACUITE D**) on the Rs.10.00 crore bank facilities of Sun Polyfilms (SP). The rating continues to be flagged as "Issuer Not-Cooperating" and is based on the best available information.

Sun Polyfilms (SPF) based out in Gujarat was incorporated in March, 2015. The firm's operations commenced from August, 2016. The firm is promoted by Mr. S.S. Rao and his family. The firm is engaged in four different lines of business, namely manufacturing of polyfilms and laminates, paper core, edible oil generating jar and bottles and job work for packing edible oil.

### Non-cooperation by the issuer/borrower:

Acuité has been requesting for data, information and undertakings from the rated entity for conducting surveillance & review of the rating. However, the issuer/borrower failed to submit such information before the due date.

This rating continues to be flagged as "Issuer not-cooperating", in line with prevailing SEBI regulations and Acuité's policies.
