Rating Rationale

Acuite has reaffirmed the long-term rating of '**ACUITE D**' (read as **ACUITE D**) on the Rs. 10.00 crore bank facilities of Sun Polyfilms. The rating continues to be flagged as "Issuer Not Cooperating" and is based on the best available information.

About the Company

Sun Polyfilms is based out in Gujarat it was incorporated in March, 2015. The firm's operations commenced from August, 2016. The firm is promoted by Mr. S.S. Rao and his family. The firm is engaged in four different lines of business, namely manufacturing of polyfilms and laminates, paper core, edible oil generating jar and bottles and job work for packing edible oil.

Non-cooperation by the issuer/borrower:

Acuite has been requesting for data, information and undertakings from the rated entity for conducting surveillance & review of the rating. However, the issuer/ borrower failed to submit such information before the due date. Acuite believes that information risk is a critical component in such ratings, and noncooperation by the issuer along with an unwillingness to provide information could be a sign of potential deterioration in its overall credit quality. This rating is therefore being flagged as "Issuer not-cooperating", in line with prevailing SEBI regulations and Acuite's policies.
