#### Rating Rationale

Acuité has downgraded the long-term rating to 'ACUITE B' (read as ACUITE B) from 'ACUITE B+' (read as ACUITE B plus) and reaffirmed the short-term rating of 'ACUITE A4' (read as ACUITE A four) on the Rs. 8.00 crore bank facilities of Shree Shami Engineering (SSE) on account of information risk. The rating continues to be flagged as "Issuer Not-Cooperating" and is based on the best available information.

#### About the Company

Shree Shami Engineering (SSE) was set up in 1994 by Mrs. Annapoorna as a proprietary concern. The company is engaged in the manufacture of stator frames, end shields, radial fan, stator core clamp, exciter frame stool, cover plate base frame parts, and turbine parts; they are used in steam/hydro/gas/wind turbine generators. SSE has one manufacturing unit located at Peenya Industrial Area, Bangalore.

#### Unsupported Rating

#### Non-cooperation by the issuer/borrower:

Acuité has been requesting for data, information and undertakings from the rated entity for conducting surveillance & review of the rating. However, the issuer/borrower failed to submit such information before the due date. Acuité believes that information risk is a critical component in such ratings, and noncooperation by the issuer along with unwillingness to provide information could be a sign of potential deterioration in its overall credit quality. This rating is, therefore, being flagged as "Issuer not-cooperating", in line with prevailing SEBI regulations and Acuité's policies.
