Rating Rationale

Acuite has downgraded the long-term rating to '**ACUITE B-**' (read as **ACUITE B minus**) from '**ACUITE B**' (read as **ACUITE B**) on the Rs. 5.00 crore bank facilities of Shri Bhavani Pharmaceuticals (SBP) on account of information risk. The rating continues to be flagged as "Issuer Not-Cooperating" and is based on best available information.

About the Company

Shri Bhavani Pharmaceuticals (SBP) is a partnership firm established in 2014 is promoted by Mr. Manohar Bakale and his family. The firm commenced commercial production in April 2015. The firm is engaged in manufacturing of injections dry and liquid with an installed capacity of 3 lakhs ampules per day. The manufacturing facility located in KIADB Industrial Area, Rayapur District, Karnataka.

Non-cooperation by the issuer/borrower:

Acuite has been requesting for data, information and undertakings from the rated entity for conducting surveillance & review of the rating. However, the issuer/borrower failed to submit such information before the due date.
