Acuité has downgraded the long term rating to '**ACUITE BB-**' (**read as ACUITE double B minus**) from '**ACUITE BB**' (**read as ACUITE double B**) and the short term rating to '**ACUITE A4+**' (**read as ACUITE A4+**) on the Rs.30.00 crore bank facilities of Innovision Limited (IL). The rating continues to be flagged as "Issuer Not-Cooperating" and is downgraded on account of information risk.

Innovision Limited (IL) is a New Delhi-based company incorporated in 2007. The company provides security services (manned and electronic), facilities management services (technical and non-technical), manpower sourcing and HR solutions, and skills development services. The company is promoted by Major Randeep Hundal (Managing Director), Lt. Col. Surendra Kumar Baliwal and Mr. Uday Pal Singh. The company presently has thirty two branches pan-India.

#### Non-cooperation by the issuer/borrower:

Acuité has been requesting for data, information and undertakings from the rated entity for conducting surveillance & review of the rating. However, the issuer/borrower failed to submit such information before the due date.

This rating continues to be flagged as "Issuer not-cooperating", in line with prevailing SEBI regulations and Acuité's policies.
