Rating Rationale

Acuité has downgraded the long-term rating to 'ACUITE B' (read as ACUITE B) from 'ACUITE B+' (read as ACUITE B plus) on the Rs. 8.00 crore bank facilities of Khandelwal Agro Products (KAP) on account of information risk. The rating continues to be flagged as "Issuer Not-Cooperating" and is based on the best available information.

About the Company

Khandelwal Agro Products (KAP) is a proprietorship firm established in 2016 by Mr. Sanket Khandelwal. The firm is engaged in grading, sorting and flouring of wheat grains and trading of agro commodities. The plant is located in Ujjain, Madhya Pradeshand it has a capacity of grading and sorting of 60 ton of wheat and processing 40 ton of flour per day.

Non-cooperation by the issuer/borrower:

Acuité has been requesting for data, information and undertakings from the rated entity for conducting surveillance & review of the rating. However, the issuer/borrower failed to submit such information before the due date.
