Rating Rationale

Acuite has downgraded the long-term rating to '**ACUITE C**' (read as **ACUITE C**) from '**ACUITE B-**' (read as **ACUITE B minus**) and reaffirmed the short term rating of '**ACUITE A4**' (read as **ACUITE A four**) on the Rs. 30.00 crore bank facilities of Technodrillers on account of information risk. The rating continues to be flagged as "Issuer Not-Cooperating" and is based on the best available information.

The downgrade is based on publicly available information which reflects that the firm's name has appeared in CRIF suit filed defaulter list for an outstanding amount as of December 2025 is Rs.6.44 Cr.

About the Company

Established in 1973, Technodrillers is a Raipur based firm promoted by Mr. Moolchand Jain and Mrs. Veena Jain. The firm is a civil contractor engaged engineering, procurement and construction (EPC) of water treatment plant, overhead water tankers and laying of water pipeline for government and semi government bodies such as Public Health Engineering department and water resource departments in Madhya Pradesh and Chhattisgarh.

Non-cooperation by the issuer/borrower:

Acuite has been requesting for data, information and undertakings from the rated entity for conducting surveillance & review of the rating. However, the issuer/borrower failed to submit such information before the due date.

Acuite believes that information risk is a critical component in such ratings, and non-cooperation by the issuer along with unwillingness to provide information could be a sign of potential deterioration in its overall credit quality.

This rating is, therefore, being flagged as "Issuer not-cooperating", in line with prevailing SEBI regulations and Acuite's policies.

gather information about the entity/industry from the public domain.
