Acuite has reviewed the long-term rating of '**ACUITE B+**' (read as **ACUITE B plus**) on the Rs. 8.00 Crore bank facilities of Abha Power and Steel Private Limited. The rating continues to be flagged as "Issuer Not-Cooperating" and is based on the best available information.

Abha Power & Steel Private Limited (ASPL) was established in the year of 2005 by Mr. Ankit Agarwal, Mr. Kalyan Kumar Ganguly, Mr. Subhash Chandra Agarwal, Mr. Harish Kumar and Mr. Sathish Kumar Shah, as a private limited company. The company is engaged in manufacturing of alloy steel casting, SG Iron casting, manganese steel casting and SS casting with the combined installed capacity of 14400 MT/ annum.

Non-cooperation by the issuer/borrower:

Acuite has been requesting for data, information and undertakings from the rated entity for conducting surveillance & review of the rating. However, the issuer/borrower failed to submit such information before due date.

This rating is therefore being flagged as "Issuer not-cooperating", in line with prevailing SEBI regulations and Acuite's policies.
