Rating Rationale

Acuite has reaffirmed the long-term rating to '**ACUITE D' (read as ACUITE D)** and '**ACUITE C' (read as ACUITE C)** on the Rs.13.89 crore bank facilities of Sri Selvam Textiles (SST). The rating continues to be flagged as "Issuer Not Cooperating" and is based on the best available information.

About the Company

Coimbatore (Tamil Nadu) based, Sri Selvam Textiles (SST) was established as a proprietorship firm in 1983 by Mr. N. Selvam. The firm is engaged in manufacturing of cotton yarn. The firm has an installed capacity of 2300 tons per annum.

Non-cooperation by the issuer/borrower:

Acuite has been requesting for data, information and undertakings from the rated entity for conducting surveillance & review of the rating. However, the issuer/borrower failed to submit such information before the due date.

Acuite believes that information risk is a critical component in such ratings, and noncooperation by the issuer along with unwillingness to provide information could be a sign of potential deterioration in its overall credit quality.

This rating is, therefore, being flagged as "Issuer not-cooperating", in line with prevailing SEBI regulations and Acuite's policies.

Limitation regarding information availability:

The rating is based on information available from sources other than the issuer/borrower (in the absence of information provided by the issuer/borrower). Acuite endeavored to gather information about the entity/industry from the public domain. Therefore, Acuite cautions lenders and investors regarding the use of such information, on which the indicative credit

rating is based.
