### Rating Rationale

Acuité has reviewed the long-term rating of '**ACUITE B+**' (**read as ACUITE B plus**) on the Rs.41.76 Cr bank facilities of Raichur Bio Energies Private Limited. This rating is now an indicative rating and is based on the best available information.

### About the Company

Raichur Bio Energies Private Limited is a Bangalore based company incorporated in 2000 under the directorship of Mr. R.P Krishnamurthy, Mr. Maram Tippanna , Mr. S Purushotam , Mr. Mylapur Laxmi Narayana and others. The operations commenced from February, 2015. The company is engaged in biomass-based power generation.

### Non-cooperation by the issuer/borrower:

Acuité has been requesting for data, information and undertakings from the rated entity for conducting surveillance & review of the rating. However, the issuer/borrower failed to submit such information before the due date.

Acuité believes that information risk is a critical component in such ratings, and non-cooperation by the issuer along with an unwillingness to provide information could be a sign of potential deterioration in its overall credit quality.

This rating is therefore being flagged as "Issuer not-cooperating", in line with prevailing SEBI regulations and Acuité's policies.

### Limitation regarding information availability:

The rating is based on information available from sources other than the issuer/borrower (in the absence of information provided by the issuer/borrower). Acuité endeavored to gather information about the entity/industry from the public domain.
