Rating Rationale

Acuite has reaffirmed the long-term rating of '**ACUITE B-**' (read as **ACUITE B minus**) and the short-term rating of '**ACUITE A4**' (read as **ACUITE A four**) on the Rs. 8.00 crore bank facilities of Win Woods Private Limited. The rating continues to be flagged as "Issuer Not Cooperating" and is based on the best available information.

About the Company

Incorporated in 2015, Win Woods Private Limited (WWPL) is a Tamil Nadu-based company engaged in imports and trading of timbers. The company is promoted by Mr. Magudhu Meeran Sheik Muthu Rowther, Mr. Divanmohideen Syedali Badusha, and Mr. Maguthu Meeran Aswath.

Non-cooperation by the issuer/borrower:

Acuite has been requesting for data, information and undertakings from the rated entity for conducting surveillance & review of the rating. However, the issuer/borrower failed to submit such information before the due date.
