Acuite has reviewed the long-term rating of '**ACUITE B**' (read as **ACUITE B**) and the short term rating of '**ACUITE A4** (read as **ACUITE A four**)' on the Rs.6.00 crore bank facilities of K H Subhod Hegde (KSH). The rating continues to be flagged as "Issuer Not-Cooperating" and is based on best available information.

K H Subhod Hegde (KSH) was established in 2000 as a proprietorship concern. KSH is a class-I civil contractor and has its registered office located at Udupi (Karnataka). KSH is engaged in civil construction of buildings and road works for clients in the state of Karnataka. The clientele of the entity includes various Government departments of Karnataka such as Udupi Public Works Department (PWD).

Non-cooperation by the issuer/borrower:

Acuite has been requesting for data, information and undertakings from the rated entity for conducting surveillance & review of the rating. However, the issuer/borrower failed to submit such information before due date.

This rating is therefore being flagged as "Issuer not-cooperating", in line with prevailing SEBI regulations and Acuite's policies.
