Rating Rationale

Acuité has reviewed the long-term rating of '**ACUITE B+**' (read as **ACUITE B plus**) and the short-term rating of '**ACUITE A4**' (read as **ACUITE A four**) on the Rs. 16.50 crore bank facilities of SUS Agro Foods India Private Limited (SAPL). The rating continues to be flagged as "Issuer Not-Cooperating" and is based on the best available information.

About the Company

Incorporated in 2014, SUS Agro Foods India Private Limited (SAPL) is a Kathua (Jammu) based company engaged in the manufacture of dairy-based product such as ghee, whole milk powder and skimmed milk powder along with curd, paneer and butter. SAPL is part of Vishwas Group promoted by Mr. Sanjeev Arora and Mrs. Upasana Arora.

Non-cooperation by the issuer/borrower:

Acuité has been requesting for data, information and undertakings from the rated entity for conducting surveillance & review of the rating. However, the issuer/borrower failed to submit such information before due date.

This rating is therefore being flagged as "Issuer not-cooperating", in line with prevailing SEBI regulations and Acuité's policies.

Limitation regarding information availability:

The rating is based on information available from sources other than the issuer/borrower (in the absence of information provided by the issuer/borrower). Acuité endeavoured to gather information about the entity/ industry from the public domain.
