Rating Rationale

Acuite has reaffirmed the long-term rating of '**ACUITE B+**' (read as **ACUITE B plus**) on the Rs.10.00 crore bank facilities of Bharkadevi Icecream. The rating continues to be flagged as "Issuer Not-Cooperating" and is based on best available information.

About the Company

Surat-based, Bharkadevi Icecream was established in 1996 as a proprietorship firm promoted by the Sachin Kotwal. The firm is engaged in manufacturing of ice creams sold under the brand name of 'Bharkadevi'. The firm has more than 700 franchises across Maharashtra, Gujarat, Madhya Pradesh among others. The Proprietor, Mr. Bherugiri Gowswami has more than three decades of experience in the ice cream business.

Non-cooperation by the issuer/borrower:

Acuite has been requesting for data, information and undertakings from the rated entity for conducting surveillance & review of the rating. However, the issuer/borrower failed to submit such information before due date.

This rating is therefore being flagged as "Issuer not-cooperating", in line with prevailing SEBI regulations and Acuite's policies.
