Acuité has reviewed the long-term rating of '**ACUITE B**' (**read as ACUITE B**) and the short-term rating of '**ACUITE A4**' (**read as ACUITE A four**) on the Rs.5.00 crore bank facilities of ASNANI BUILDERS AND DEVELOPERS LIMITED (ABDL). This rating is now an indicative rating and is based on best available information.

Asnani Builders & Developers Limited (ABDL), incorporated in 1992, is a Madhya Pradesh-based company promoted by Mr. Om Prakash Kriplani, Mrs. Jaya Kriplani, Mr. Vishan Das Asnani and Mrs. Adita Asnani. ABDL is engaged in providing land to real estate players under Joint Venture. Further, the company has MSO license and is starting their own news channel called 'Anaadi TV' from July, 2018.

Non-cooperation by the issuer/borrower

Acuité has been requesting for data, information and undertakings from the rated entity for conducting surveillance and review of the rating. However, the issuer or borrower failed to submit such information before due date.

This rating is therefore being flagged as "Issuer not-cooperating", in line with prevailing SEBI regulations and Acuité's policies.
