**Rating Downgraded, Reaffirmed and Issuer not co-operating**

**Rating Rationale**

Acuite has downgraded the long-term rating to '**ACUITE B**' (read as **ACUITE B**) from '**ACUITE B+**' (read as **ACUITE B plus**) and reaffirmed the short term rating of '**ACUITE A4**' (read as **ACUITE A four**) on the Rs. 6.00 crore bank facilities of Micro Plastics on account of information risk. The rating continues to be flagged as "Issuer Not-Cooperating" and is based on the best available information.

**About the Company**

Established in 1990, Micro Plastics a Bangalore, Karnataka based proprietary concern engaged in manufacturing of plastic injection molding components. Entity was promoted by Mr. M.N Kamath. Currently, the entity has one manufacturing unit in Bangalore.

**Unsupported Rating**

**Non-cooperation by the issuer/borrower:**

Acuité has been requesting for data, information and undertakings from the rated entity for conducting surveillance & review of the rating. However, the issuer/borrower failed to submit such information before the due date.
