#### Rating Rationale

Acuité has reaffirmed the long-term rating of 'ACUITE D' (read as ACUITE D) on the Rs. 6.21 crore bank facilities of PM Control Equipment Private Limited (PMCE). The rating continues to be flagged as "Issuer Not Cooperating" and is based on the best available information.

#### About the Company

PM Control Equipment Private Limited (PMCE), a West Bengal-based company was established in 2001. Previously, the company was a proprietorship concern by the name of 'Power Management' from 1991 till 2001. Later, the constitution of the company was changed. The company is engaged in the manufacturing of High Tension, Low Tension, customised panel boards and switch gears for different industries. The directors of the company are Ms. Samiran Bhattacharjee and Mr. Nikunj Toshniwal.

#### **Unsupported Rating**

#### Non-cooperation by the issuer/borrower:

Acuité has been requesting for data, information and undertakings from the rated entity for conducting surveillance & review of the rating. However, the issuer/borrower failed to submit such information before the due date.
