Acuité has reviewed the long-term rating of '**ACUITE B+** (read as ACUITE B plus) and the short-term rating of '**ACUITE A4** (read as ACUITE A four) on the Rs. 10.00 crore bank facilities of Comsat Systems Private Limited. The rating continues to be flagged as "Issuer Not-Cooperating" and is based on best available information.

Comsat Systems Private Limited is a Hyderabad-based company incorporated in the year 1982 promoted by Mr. John Saripally. It is engaged in manufacturing of antenna systems for satellite communications and other antenna's in UHF/VHF frequencies. The company has taken technical knowhow from ISRO, Ahmedabad for C / Ext C Band feeds & Antennas for 11 M & 7.5M diameter. So far, the company has installed more than 5000 antennas all over India.

Non-cooperation by the issuer/borrower:

Acuité has been requesting for data, information and undertakings from the rated entity for conducting surveillance & review of the rating. However, the issuer/borrower failed to submit such information before the due date.

This rating is therefore being flagged as "Issuer not-cooperating", in line with prevailing SEBI regulations and Acuité's policies.
