#### Rating Rationale

Acuité has reaffirmed the long-term rating of '**ACUITE B**' (**read as ACUITE B**) on the Rs.10.00 crore bank facilities of G R Overseas. The rating continues to be flagged as "Issuer Not-Cooperating" and is based on the best available information.

#### About the Company

Karnal-based, G R Overseas (GRO) was established in 2014 by Mr. Pankaj Wadwa and Anil Kumar Wadwa as a partnership firm. The firm is engaged in the processing of basmati, non-basmati and parboiled rice. The manufacturing facilities are based out in Karnal, Haryana, with a capacity of 8 MT per hour.

#### Non-cooperation by the issuer/borrower:

Acuité has been requesting for data, information and undertakings from the rated entity for conducting surveillance & review of the rating. However, the issuer/borrower failed to submit such information before due date.

This rating is therefore being flagged as "Issuer not-cooperating", in line with prevailing SEBI regulations and Acuité's policies.
